

Event Sustainability Policy

Scope

The scope of the event sustainability policy relates to the management of 'major events' within the bowl at Wembley Stadium. Major events are defined as events involving 12,000+ spectators, which use the main interior bowl of the stadium and pitch. This excludes any events held behind closed doors (BCD). It covers all activities from the conception and planning to the implementation, review and post-event activities.

Our Values

Sustainability is integral to our ambition to provide a world leading, inspirational venue. Through our sustainable event management system, which has been awarded ISO 20121 certification, we aim to demonstrate leadership in the field of event sustainability management.

We aim to align our event-related activities and subsequent communication to our PRIDE values, which reflect The FA Group's wider 2024 strategic plan.

- Respectful We operate with respect for people and planet

Our Policy

The FA Group recognises that our major events have positive and negative environmental, social and economic impacts. With the launch of the FA's Sustainability Strategy, Playing for the Future, as well as through evaluation of global and sector sustainability trends, and stakeholder priorities, we have identified the following impact areas as key to address for 2023:

- 1. Shoot for Net Zero reduce carbon emissions within our operational control across Scope 1, 2 and 3, focusing on the key operational areas of: energy and climate action and transport.
- Save our Resources minimise the impact from waste, reduce water consumption, maximise water
 recycling opportunities and protect biodiversity across our venues, focussing on the key operational
 areas of waste management, water management, responsible procurement and charity and
 community.

- 3. Make an Impact ensure good governance and support wider change through increasing awareness of environmental sustainability practices across football, focussing on the key operational areas of transparency and communication.
- 4. Health and safety maintain a safe and healthy venue for employees and customers.
- 5. Diversity, equality and inclusion Make Wembley Stadium a venue for all and enhance diversity and inclusion.
